ORDER

In exercise of powers conferred under Section 24 of the Disaster Management Act, 2005 to Commissioner, BBMP through Order No: RD 158 TNR 2020 dated 14-04-2020 of Government of Karnataka and in accordance with the Circular No. CHS/392/2020 dated 21-05-2020, Containment Zones are to be identified in view of COVID-19 Positive cases, and Clusters are to be identified for Containment where there is an aggregation of epidemiologically linked COVID-19 cases in a limited area, to prevent the further spread of infection.

The following area (s) is/are hereby declared as Containment Zone (s) to prevent the spread of infection in the community.

The codes used for Containment Zone Identification represent the following:

1. "A" is the street which has the residence of the COVID-19 Positive person; with a demarcated perimeter, in case if the road length is more.
2. "AP" is an Apartment complex – the particular floor which has the residence of COVID-19 Positive person and an immediate floor above and below respectively.
3. "S" is the Slum area (notified or otherwise), the street which has the residence of the COVID-19 Positive person and an immediate street on either side (next and behind) respectively.
4. "CL" is an aggregation of COVID – 19 Positive Cases grouped which are epidemiologically linked.

It is directed to all concerned that as per the SOP for Containment Zones issued by the undersigned on 23-05-2020, all activities are to be carried out in the Containment Zone for the period mentioned above.
